

Fiber and Folk Art Entry Application

April 29 - June 21, 2019

Submissions must meet the following criteria:

- Fiber Art: artwork where fiber is a primary medium of the piece
- Folk Art: visual art made in the context of folk culture; can have practical utility or be decorative; made within a popular tradition rather than fine art
- Artwork may be 2-dimensional or 3-dimensional.
- Artwork to be hung on walls must be gallery-ready. See website **Gallery Ready** for specifications. Works not delivered gallery ready will be declined at delivery.
- Artist must be at least 18 years of age.
- All forms and images for entries must be submitted by application deadline of April 6, 2019
- This is a juried show, but not a judged show. All submissions may not be selected. Space is limited in this gallery, and the Board of Arts Alpharetta encourages the selection committee to gather a quality show that reflects the theme and meets all criteria.

Artists may submit more than one work. Each submission requires a non-refundable application fee of \$10.00. If additional space is needed for submissions, please copy the table below onto a separate sheet to include with application. Artist will be notified of acceptance by April 13, 2019.

Once selected, artwork must be delivered to the Alpharetta Arts Center at 238 Canton Street, Alpharetta, GA 30009 only on **APRIL 27, 2019 between 9:00 am and 12:00 pm**. Artists will be allowed to exhibit their work as available for sale. All sales transactions will be conducted by Arts Alpharetta. Arts Alpharetta will collect and remit sales tax in accordance with Georgia tax laws. Artists will be given a tax form to complete and retain for their records regarding sales tax. Arts Alpharetta will retain a 30% commission on all sales. Artists may indicate that a piece is not for sale (NFS in example above).

Artwork that is sold during the exhibit shall remain in the exhibit for the duration of the show. The buyer may retrieve the work at the dismantle date of the exhibit. All artwork must be retrieved by artist or new owner on JUNE 21, 2019 between 2:00 pm and 4:00 pm.

INSURANCE: The Alpharetta Arts Center, as a division of the Alpharetta Recreation, Parks, and Cultural Services, shall insure the work per artist's specifications noted by terms as follows:

The property insurance carrier will provide a \$500,000 blanket limit with a \$25,000 maximum any single unscheduled item subject to the \$5,000 deductible. The City of Alpharetta would pay deductible.

Artworks with a value greater than \$25,000 require a schedule. The artist must notify the Arts Center at application deadline of the value of each work. The Arts Center shall be responsible for the safekeeping of all consigned works.

LIMITED WAIVER AND RELEASE. In consideration of the City of Alpharetta (the "City") and Arts Alpharetta providing permission to place and show my artwork (the "Work") in the City Arts Center, I hereby assume all responsibility for, and risks and hazards of, placing the Work in the Arts Center. In addition, I do hereby release the City of Alpharetta and Arts Alpharetta, including all of their respective officials, officers, employees, sponsors, organizers, supervisors, volunteers, participants and all other agents, of any and all claims, demands, rights, causes of action of whatever kind and nature arising by reason of, all known and unknown, foreseen and unforeseen, bodily and personal injuries, damage to property, including without limitation the Work, and the consequences thereof, resulting from placing the Work in the Arts Center. While I understand that the City of Alpharetta and Arts Alpharetta may carry certain insurance as they deem appropriate to insure their respective interests, I acknowledge that I should not rely on such insurance, and should provide such in-surance or other security I deem appropriate to protect my interests.
